**Release of Liability**

The undersigned, for and in consideration of the use of the Way-Ont Saddle Club, Inc. property for the purpose of horse back riding or any related type events and activities, do for myself, by heirs, executors and assigns, make the following representations, releases, and warranties:

1. That I am aware that there is some risk connected with the use of horses in any event (Gaming, Team Penning, Roping, Pleasure, Trail Riding, etc.)
2. That despite my awareness of the risk which may be associated with the use of horses in any type of event, I freely and knowingly consent to the risks because I feel that the advantages of using the facilities outweigh these risks;
3. That I have received no representation from the Way-Ont Saddle Club, Inc., any of its officers, members or agents, regarding the damage or death to my horse or to me (or to my children) from the horse back riding events they offer. I have arrived at the decision to participate solely on my own without any persuasion from the Way-Ont Saddle Club, Inc., its officers, members, agents, etc;

That should I or my horse (or my children) suffer injury or death or damage in any way as a result of the horseback riding events, or the facilities owned by the Way-Ont Saddle Club, Inc., I will not attempt to obtain any recovery from the Way-Ont Saddle Club, Inc., its officers, members, agents, etc., but will instead accept these injuries or death or damages as a necessary consequence of the horseback riding events I have sought out.
5. That I remise, release and forever discharge and by these presents do for my heirs, executors and administrators remise, release and forever discharge the said Way-Ont Saddle Club, Inc., its officers, members or agents, their heirs, executors, administrators, successors, and assigns, of and from any and all manner of action and actions, cause and causes of action, suits, damages, judgements, executions, claims for personal injuries, death, property damages and demands whatsoever; in law or in equity, which I ever had or now have or which my heirs, executors or administrators hereafter can, shall, or may have against the Way-Ont Saddle Club, Inc., for, upon, or by reason of any matter, cause of thing whatsoever, from the beginning of the world to the day of the date of these presents.
